Challenge overview

Office of Career, Technical, and Adult Education

OCTAE administers and coordinates programs related to:

- Adult education and literacy: enabling adults to acquire & necessary basic skills to function in today's society. &
- Career and technical education: helping students prepare for occupations in the 21st century workforce.
- Community colleges: providing national leadership to strengthen the role of community colleges.

Ed Prizes

Ed Prizes is a series of challenges run by the U.S. Department of Education in collaboration with innovators across the country.

These challenges strengthen the competitiveness of the American workforce by preparing learners for the careers of today and tomorrow.



Current Challenges



CTE Mission: CubeSat

Launched August 18, 2020

CTE Mission: CubeSat is a national challenge to build technical skills for careers in space and beyond. ED invites high schools to bring space missions to students by designing and building CubeSat prototypes.



Rural Tech Project

Launched June 30, 2020

The Rural Tech Project is a national challenge to advance rural technology education. The U.S. Department of Education invites high schools and local educational agencies to propose technology education programs that use competency-based distance learning.

Rethink Adult Ed Challenge is a \$750,000 U.S. Department of Education competition to advance pre-apprenticeships.

We are seeking designs for adult education programs that better prepare learners for apprenticeships and beyond.

What is a preapprenticeship?

A pathway into a well-paying, rewarding career

Pre-apprenticeship programs help adults enter, prepare for, and succeed in apprenticeships and other roles with opportunities for progression.

Programs typically target groups that are underrepresented in apprenticeships.

Programs exist across a range of industries — from construction to healthcare — and can be structured in different ways.

What do pre-apprenticeships offer?

- Career exposure: Expose adult learners to different occupations and opportunities.
- Skill advancement: Equip learners with both academic and workplace skills.
- Job readiness: Introduce learners to workplace culture.

- Holistic support: Provide financial assistance and access to support services.
- Guided transition: Explain the apprenticeship system, facilitate the transition into an apprenticeship program or similar role, and help cover upfront costs.

What are the benefits of pre-apprenticeships?

"It's a great opportunity to try and **figure out what you want to do**. I started the program wanting to be an electrician, and ended up becoming a laborer."

"... having an instructor to answer questions and provide **constructive feedback** was invaluable in actually mastering the material."

"It opened new doors to me that I didn't necessarily know about. The program accelerated the key skills needed to do that work. That was exciting and liberating."

Why are we running this challenge?

- 1. Learners often aren't aware of pre-apprenticeships, so they miss out on these opportunities.
- 2. There aren't enough preapprenticeships — particularly in growing industries like technology and healthcare.
- 3. Adult ed providers would like more guidance and support to design and deliver preapprenticeships.

How will this challenge help?

Through this challenge we aim to:

- Spur the creation of **new adult pre-apprenticeship programs** across a range of industries.
- Increase adult educators' capacity to deliver high-quality pre-apprenticeship programs.

Why should organizations participate?

Opportunity to be at the forefront of adult preapprenticeships

Who is eligible?

Participating organizations can be working in **any industry**, **anywhere in the United States**.

Organizations must be:

- An eligible provider, as defined in section 203(5) of WIOA.
- Receiving AEFLA-funding to provide adult education and literacy services, at the time of application and for the duration of the 10-month Challenge.

Challenge details

Stage overview

Stage 1: Open submissions

AEFLA-funded adult education providers are invited to submit preliminary designs for preapprenticeship programs.
Submissions close on **November 25, 2020.**

No prior experience with preapprenticeships is required.

Up to 100 finalists will progress to Stage 2.

Stage 2: Virtual accelerator

The virtual accelerator will run from **Feb – June 2021**. It will include a mix of virtual resources, activities, and webinars with subject matter experts. At the end of the accelerator, finalists will be invited to submit more detailed program proposals.

Following judging, winners will be announced in **summer 2021**.

Submissions

Stage 1 submission: preliminary design

- Evidence of the industry demand that the preapprenticeship program may meet.
- An overview of the adult education activities the program may deliver.
- A description of prospective adult learners and potential apprenticeship partners.
- Your team's expertise.

Stage 2 submission: program proposal

- A description of the proposed pre-apprenticeship program, including mode of delivery and structure.
- An overview of the workplace and academic skills the program will address.
- Evidence of partnership development.
- Your team's expertise, plus a program budget and list of target outcomes.

Stage 1 selection criteria

Local or national need

Extent to which the entrant describes local or national industry demand for more skilled workers in the relevant field.

Skill advancement

Extent to which the entrant identifies appropriate adult education and literacy activities needed to help adult learners prepare for apprenticeships or other industry roles with opportunities for progression.

Team

Extent to which the entrant demonstrates the necessary skills, experience, and commitment needed to advance its pre-apprenticeship program concept.

Industry connection

Extent to which the entrant identifies quality apprenticeship programs and other potential industry partners.

Learner focused

Extent to which the entrant demonstrates an understanding of its prospective adult learners and their specific needs.

Stage 2 selection criteria

Local or national need

Extent to which the entrant demonstrates local or national industry demand for more skilled workers in the relevant field.

Skill advancement

Extent to which the program will deliver adult education and literacy activities that will equip participants with the necessary academic, occupational, and workplace skills and credentials needed to enter apprenticeships or other industry roles with opportunities for progression.

Team

Extent to which the entrant demonstrates the necessary skills, resources, and commitment to establish and deliver a high-quality preapprenticeship program beyond the challenge.

Industry connection

Extent to which the entrant has established partnership commitments to facilitate placements in apprenticeships or other industry roles with opportunities for progression.

Learner focused

Extent to which the program reflects the interests and needs of the target adult learners, such as through tailored outreach strategies and support services.

Prizes

Total prize pool

\$750,000

A judging panel will review Stage 2 submissions and select:

- One grand-prize winner to receive \$250,000.
- Up to five runners-up to receive at least \$100,000 each.

How to enter

To enter the challenge you will need to do the following by 11:59 p.m. ET on November 25, 2020:

- 1. Create a Luminary Lightbox[™] account.
- 2. Review the Stage 1 selection criteria.
- 3. Complete and submit the Stage 1 submission form at: rethinkadulted.com.

Please plan to complete all of these steps well ahead of the deadline. That will allow time to resolve any potential technical issues.
